Sgt. Koehler told me that MCGOVERN left a message at the Attorney General's Office and stated that she knew RASMUSSEN.

I called and left a message for MCGOVERN on March 7, 2019. MCGOVERN left me the following messages over the next few days:

- March 8, 2019: MCGOVERN stated that Terry lived with her, and believed that he is related to her rapists Birch and Steven Davis. MCGOVERN stated that she thinks that Terry worked for Otto Davis, the father of Steven and Birch Davis. MCGOVERN stated that her family is telling her this is all in her mind, and also that someone is stalking her.
- March 12, 2019: MCGOVERN stated that she posted information about RASMUSSEN on Twitter. She stated that she believes the police trying to cover it up in California along with a dirty FBI Agent. She stated that RASMUSSEN lived with her on an Indian Reservation in Arizona and in a house on Prasa Road in Woodland Hills California.
- March 13, 2019: MCGOVERN stated that she was going to file a new claim with California Victim's Crime Board about RASMUSSEN. She mentioned the names of serval other people, along with Joe DeAngelo, the "Golden State Killer", who she has already filed claims against. MCGOVERN stated that she believes that RASMUSSEN is related to them. MCGOVERN stated that she is sick of being lied to, and was going to use my name and telephone number in her claim against RASMUSSEN.

On March 13, 2019 at approximately 1230 hours I called and spoke with MCGOVERN by phone. The following are some of the topics that were covered during my conversation with MCGOVERN; however this is not a complete compilation of all of the facts that arose:

- MCGOVERN told me that she had been raped by Ben Stein, Birch Davis, and Steven Davis when she was 6 years old. It should be noted that Ben Stein is a well-known television personality.
- MCGOVERN rambled about her childhood and how she traveled the county. I had to specifically ask her several times about RASMUSSEN.
- She stated that her house burned down in Hadley, New York in December of 1980 and she remembered RASMUSSEN being there.
- MCGOVERN stated that she moved from New York to Huston, Texas. She then moved to an Indian Reservation in Arizona, and stated that they picked up an indivial she knew as the "Arizona Man" along the way. MCGOVERN stated that she only recently found out that the "Arizona Man" was RASMUSSEN after hearing about him on a podcast.
- MCGOVERN stated she thinks that this man, who she knew as Terry, was RASMUSSEN because of his appearance and the fact that he worked for Paul Otto Davis, who she said is the father of her attackers, Birch and Steven Davis.
- MCGOVERN stated that she was going to file a claim on RASMUSSEN with the California Victim's Crime Board. I informed her that RASMUSSEN died in prison in 2010. She asked me what he died from, and I told her that I did know. She asked me if he was a "non-secretor". I asked her what that was, and she told me that it is a blood type, and the Davis' were non-secretors and had "magic blood" and if RASMUSSEN was a non-secretor, this would mean he was connected with them.
- I asked MCGOVERN if she knew RASMUSSEN by any name other than Terry, and she stated that she did not. She said that he talked about having little girls.
- I attempted to obtain more information about RASMUSSEN from MCGOVERN; however I was unable to do so.
- MCGOVERN told me that she has spoken with Detectives January and Dorbecker of the LAPD about this already.
- MCGOVERN gave me the names of several of her family members.
- MCGOVERN asked me when I would tell her if Terry was actually RASMUSSEN, and I told her that I did not know when, if ever it would be able to be confirmed. MCGOVERN was obviously displeased with that answer and hung up the phone.

After reviewing several pages, I saw that MCGOVERN posts nearly constantly about her sexual assault and the people involved. Her behavior is erratic she appears to be delusional.

It is highly unlikely that MCGOVERN has any connection to RASMUSSEN, and only focused on him after hearing about him on a podcast.
