- \* I have filed a restraining order against William Birch Davis & the RO hearing is with Judge Amerian at the Van Nuys Courthouse.

- \* I have already subpoenaed the LA District Attorney & members of the LAPD last year & plan on filing a legal complaints with the California State Bar against Mike Feuer, Jackie Lacey, John Morris & others involved in my cases & their violations of my Marsy's rights & rights as a victim of violent crimes.
- \* I am going to be homeless in less than a month & I have an eviction lockout date.
- \* They (LAPD, The State of California, My government & several state & city agencies involved) have violated my Marsy's rights since the law went into effect. I believe they have had Steven Dale Davis's DNA on file for decades & I have a right to know where my attackers are and I reported Steve Davis & my assault & to Boston Children's Hospital in Dec. 1980 See

attached medical records. Boston Children's Hospital was negligent in their care of me in 1980 and I am seeking all records from that time regarding my assault & torture & I filed a complaint with Boston Police Department because Det Goff left me a vm stating there was no police report filed for my assault.

- \* I believe I have a case open at the FBI & they are violating my civil rights/marsy's rights daily.
- \* They violate my rights daily & let other ex FBI agents & their associates attack and exploit me.
- \* I have several cases open with the LAPD ;
- \* cyber crimes, commercial crimes (my yahoo email hacked for four days),
- \* stalking, annoying threatening death threat obscene phone calls, child rape & torture, kidnapping, attempted murder, strangulation, child photos/exploitation, child molestation, more annoying phone & hang up calls , Ben Stein photos ( I am not sure if the children in the Ben Stein photos are okay & I believe there has been a decades long Media & FBI coverup on his behalf & he is a public danger & now my life is in danger because of coming forward with my story & what I discovered when doing due diligence on my own child sex crime case with him & reporting him to the police & Jim Clemente from 2011-2017 & then I realized Jim Clemente & Paul Holes & Michelle McNamara & their associates & my relatives , et al were exploiting me in a predatory sick way) & stalking defamation case, et al

## Morgain McGovern Declaration

I, Morgain McGovern, hereby declare and state as follows; I am a pet caretaker, farmer, actor, writer, performer journalist & blogger. I have severe medical condition now PTSD, Trauma, Anxiety, ( diagnosed several times from March 2018 to September 2019 by Doctors, see attached PTSD diagnoses & codes ) my illness is caused by these traumas that have recently occurred & in the past, and the scant information I received about the status of the men who raped & tortured me when i was a child & also people who are actively exploiting me and have apparently been scheming on me and my life for decades now.

My Marsy's Rights are violated daily. My Civil Rights are violated daily. I demand law enforcement & the state of California honor my rights as a victim of a violent crime immediately. I need my income loss replaced & emergency relocation expenses paid for immediately. My life has been obliterated because of the LAPD's negligence & willful violations of my Marsy's Rights regarding my cases.

I have trauma and mental health struggles coping with my flashbacks and ongoing CPTSD hat I have been struggling with my entire life because of this story and the recent events that have occurred have obliterated whatever I had built for myself & not only was my safety & income & psyche destroyed, my pet sitting business was attacked & destroyed, my sense of safety.

My safety is in permanent jeopardy because of recent events & the people in law enforcement and media who exploited me for this evil story & my horrific rape and torture that still torments me daily as I have no peace or answers & now no home or credibility, health or income. I am disabled and unable to function.

My faith and health and income and livelihood & right to peace & my civil rights have been obliterated.

My entire life I have been looking for answers about my assaults when I was a child & the scope of this story and the destruction and damage this is has caused me is hard for me to comprehend. I grew up watching Ben Stein on TV.

This is a declaration regarding the permanent restraining order I am requesting against Steven Dale Davis & William Birch Davis & their associates.

I still cannot find William Birch Davis & Detective Doerbecker of the LAPD told me in December of 2018 he was unable to find Birch Davis. I am going to file a new restraining order against William Birch Davis, his location is unknown. I plan to serve him at his sister's house. He may be living with her.

I fear for my safety & my health and life have been obliterated from this story.

The XG Productions story, Ben Stein story and the Davis family story and DeAngelo story has destroyed my mental health, my physical health, my psyche and my faith. These people were allowed to attack and/or exploit me for years.

My rights are violated daily (Marsy's rights) and I am filing formal complaints against several district attorneys and people who work for the state of California and actively schemed on me and my life &/or allowed others like Jim Clemente & Paul Holes & Michelle McNamara to do so. The state & gov allowed people to exploit & harass and assault me because of my child sex crimes & the violent & sick men in the story who were also allowed to assault me because of the State of California's negligence &/or corruption.

Steve Davis is the man who came into my room (that I fully remember him clearly at the beginning of our assault & attempted murder) when I was six & participated in my child rape and torture and attempted murder the night my sister and I were assaulted and tortured in my bedroom when I was six. I have other memories of being outside and blindfolded and in the living room at a part blindfolded and naked but I don't know if it is the same night.

He and his associates may have photographed me and my sister when they assaulted & raped us. I believe his brother Birch was there as well as Joe DeAngelo and possibly Terry Rasmussen. I honestly don't remember who was there besides Steve Davis but I know other people or a person was there and there are other instances I have of a party and being blindfolded and naked in the living room and outside by the pool. My bedroom had a back door that led outside directly to the swimming pool.

I remember being blindfolded and brought out to the living room and other people were there I don't know if it was the same night or another time. I was also molested by Terry Rasmussen who lived with us in a few states and I gave a detailed report to LAPD Devonshire on October 30th 2019.

I have parts of my rape blacked out but I know Steven Dale Davis raped & tortured me and my sister that night. I believe other men were there that night. We have hospital records from 1980.

We had been stalked a few weeks or months before our rape because we saw men in our bedroom window, not Birch & Steve, but other white caucasian men spying on us in the middle of the night in our backyard window. They were in our backyard. Staring in our bedroom window. I was six and my sister was eight. We were both sexually assaulted and tortured that night by Steve Davis & I think Birch Davis & other men might've been there.

Our rape was reported to Boston Children's Hospital in Dec 1980. My sister has a hospital record there that documents her rape and I was in the bed with her and reported by sexual assault to the nurses there. Also, I was strangled by Steven Dale Davis and reported a sore throat/ throat injury to my doctor, Dr. John Graef of Boston Children's Hospital.

\*See attached hospital records & police reports from 2009-2019 regarding my child rape and torture committed by Steve Davis & his accomplices, which include Joe DeAngelo, Terry Ramussen et al. I believe Steven Dale Davis is the non-

secretor with a rare PGM blood type, not Joe DeAngelo. I also think his brother Birch Davis helped them commit crimes & participated in rapes. I think Birch is also a non-secretor with a rare PGM blood type.

I believe Birch & Steve Davis are related to Bruce Davis of the Manson family and their father Paul Otto Davis is the Zodiac Killer or connected to that case. I believe their sisters Belinda, Beth & Blair all knew. I believe that Birch & Steve & Joe DeAngelo are responsible for Belinda Davis's murder & her boy Jeremy Margarit in the explosion that killed them in August 3rd, 1980 on Cabrito road in Van Nuys.

I believe Joe DeAngelo or Birch Davis or their accomplices may have been the man or men who were stalking me recently from 2007-2017 via telephone.

Joe DeAngelo knew Birch & Steve Davis and the Glasby Brothers who were all frequent visitors at my house on 9020 Balcom Street, Northridge, CA. in 1979 and 1980.

Joe DeAngelo knew Birch & Steve Davis, Paul Otto Davis & Terry Peder Rasmussen who knew Paul Otto Davis ( Zodiac killer &/or Santa Rosa murders) and I believe they may have committed crimes together.

I lived with my mother and sisters & Terry Rasmussen New York, Texas & California from 1980 to about 1983 or 1984. I believe my relatives Nora & Bob Ackerley met Terry Rasmussen when we all lived in Houston in West U, they lived on Harvard Street & we lived on Centenary Ave, I think we lived two streets away from each other for about 6-8 months I am not sure I was 7 years old.



My Aunt & Uncle knew we were treated for sexual assault at Boston Children's Hospital & that our house was torched & burned to the ground in Stony Creek, New York on Christmas 1980 right before we moved to Houston in January 1981. The arson records should be on file in Warren County & I gave a detailed statement to Detective Steven Stockdale Glens Falls, NY around June 2019.

I also filed a police report with LAPD Topanga in May 2019 and my case there with Detective Padilla is still open. I have made numerous requests to the LAPD for my full crime report about Terry Rasmussen & death confirmation or location info on any of these violent men who attacked me & I have 5 active open cases now with the LAPD.

My last meeting with the LAPD in search of peace & basic safety answers & my income loss replaced was on November 19th 2019 at LAPD HQ downtown LA with Grace of Michel Moore office & Nancy Pantoja of records & Det Steve Boylls ( see attached cards & evidence) request all of my full crime reports and for the LAPD to honor my Marsy's rights immediately.

They stated they would gather the new updated records with the update Oct 30 2019 LAPD Devonshire child rape kidnapping and torture report I filed with them in 2009 with Detective January.

I've included evidence regarding my journey to find Birch & Steve Davis to get closure and the various other disgusting people in my story who attacked and

defrauded me because they wanted to use my child rape & torture story for their books, podcasts and tv deals.

I believe Joe DeAngelo, Birch Davis, Steve Davis and Alex Ewing and the Glasby brothers were all at our house in 1979 and 1980 and were part of my attack or helped plan it.

I also believe they may have photographed or video recorded our child rape and torture the night of my rape.

**In June 2017**

I was told by Erika Hutchcraft at the OCDA office in writing, several times, or led to believe, I am connected to the “Golden State Killer” case and Joseph James DeAngelo.

Joseph James DeAngelo was at my home in 1979-1980 several times and was friends with my rapists Birch & Steve Davis and the Glasby Brothers were also their friends and our pool guys. They had other accomplices but I do not know what their names are or how to locate them.

Some of these men were part of my child rape and torture with my sister Katie around May 1980 when I was six years old.

We reported our rape in 1980 to Boston Children's hospital. I reported them again in 1988. See attached evidence & my hospital record from Dec 16th, 1980. I reported my rape to them.

Police reports;

I am a child rape and torture victim and survivor and also am a victim of recent stalking (see 2009, 2010, 2016 & 2017 LAPD police reports and law enforcement responses) My email was hacked in March 2018 so there is an active LAPD investigation into that .

There is also a current LAPD internal investigation regarding my botched LAPD Devonshire 2009 /1980 child rape report I made to LAPD Devonshire & Birch's escape & ID'ing the wrong Steve Davis.

I've attached case numbers for the numerous police reports I've filed regarding my child sex crimes and then being stalked from 2007-2017 from an unknown man or persons.

I've attached texts, emails and correspondence with my relatives trying to get closure and safety in my child sex crime cases.

I also believe Peter & Jim Clemente used my sisters as their agents to attack, defraud, harass, stalk and exploit me.

These people in my story have completely robbed me of justice and dignity in my child rape story and I believe Spencer Gordon should be disbarred and Jim Clemente & Peter Clemente put in prison for exploiting me and attacking me. They used my child rape information and life story and gave my information to Michelle McNamara & Paul Holes for her book "I'll Be Gone In The Dark" I will also be giving any evidence I have, and a copy of this letter to Joe DeAngelo, Steven Dale Davis, Bruce Davis & Alex Ewing in their RO papers, because they are related to my child sex crime case that Jim Clemente, Paul Holes, Peter Clemente, Spencer Gordon and their associates exploited for their income.

I declare under penalty of perjury under the laws of the State of California that the foregoing Declaration is true and correct.

I first spoke with Grace Devora of Michel Moore's office & she came back with Detective Boylls. Grace said something about my cyber crimes case that it protects both parties if I don't know who hacked into my email account for four days. The LAPD is violating my Marsy's rights daily regarding the stalking/cyber crimes report # DR 18 09 157 87

I requested my 5 full crime reports with updated supplemental reports, all copies of my full updated current crime reports to Naomi Pantoja of records & she said Doris would be my contact for records & Naomi said the LAPD will give me full updated crime reports, including the October 30th 2019 LAPD Devonshire regarding Joe DeAngelo, Terry Rasmussen & the Davis family & their associates & Jim Clemente & XG Productions & other people & media & my relatives exploiting and harassment. Still waiting for an email or mailed copies.

I have an upcoming restraining order hearing against Joe DeAngelo on November 27th and need an update from the LAPD about the status of my cases. The LAPD & FBI are violating my Marsy's rights (code 13950-13974.5) on a daily basis.

I am on medication now because I have severe PTSD from these traumas.

I have been diagnosed with severe PTSD until March 2021.

DECLARATION OF MORGAIN MCGOVERN

I, Morgain McGovern, hereby declare and state as follows: I am a pet caretaker, actor, writer and performer.

I am also a child rape & torture victim/survivor and victim/witness in a federal criminal murder case involving William Birch Davis and Stephen Brett Davis & Joseph James DeAngelo.

My case number is 1786-07980 per OC District Attorney Erika Hutchcraft. Her case is the Golden State Killer case. *See attached evidence*

All of these men were part of my child rape and torture with my sister Katie around May 1980 when I was six years old. They had other accomplices but I do not know what their names are or how to locate them. I've attached evidence to support my claims and emails from various law enforcement agencies, state sponsored victims advocate groups & personnel.

The facts set forth herein are of my personal knowledge and I could and would truthfully testify thereto if called upon as a witness.

I submit this declaration in support of my own defense in connection with the false and defamatory allegations that were made by Spencer Gordon, Peter Clemente and Jim Clemente about me to the courts in the restraining order they filed against me (Jan 14th, 2019) after I filed restraining orders against Jim & Peter Clemente on Jan 11th, 2019.

This is my statement in response to the temporary restraining order Spencer Gordon filed on behalf of his clients/employers, James T. Clemente (aka Jim Clemente, "Jim") and Peter C. Clemente ("Peter") on January 14th, 2019

They filed this restraining order against me AFTER I filed a restraining order against Jim and Peter Clemente on Jan 11th, 2019 for their disgusting, exploitative and damaging behavior towards me that I believe constitutes & violates civil and criminal law.

I can & will establish the required elements against Spencer Gordon, Jim Clemente & Peter Clemente to the courts that proves they deliberately lied about me & my allegations to them in their statements in RO 19VER000088 *See attached.*

*My allegations against them are completely true and I have records from law enforcement & other state agencies regarding my attacks as a victim/witness in the Golden State Killer case & I have several case numbers & police reports regarding my child rape and torture and child sex crimes.*

January 21 2019

They have demonstrated towards me and my life an unwavering desire to attack, defraud, stalk, exploit & violate me & my life and exploit my child sex crime story for their income/pecuniary gain.

I also believe they used my sisters & relatives as agents to deliberately mislead, tamper, intimidate, harass & exploit me and my child sex crime cases involving William Birch Davis, Stephen Dale Davis, Joe DeAngelo, their associates & separate child sex crime committed against me by Ben Stein.

I previously also filed a restraining order against Jim Clemente (Case No.: 18VER001715) which was dismissed without prejudice because I was unable to locate him/serve him and was sick from the extreme & permanent trauma he and his associates caused my life with their sick behavior.

See attached copy of attempt to serve Jim Clemente at Brynhurst ave.

I have since refilled the RO against him & used his work address., "X-G Productions".

I also filed new RO's against Spencer Gordon & Peter Clemente which have been presented to the L.A Sheriff to serve them at XG Productions.

I have evidence against Jim Clemente, Peter Clemente, Spencer Gordon and their associates which constitutes harassment, fraud, stalking & exploitation and what I believe is criminal and violated criminal and civil law. I have attached evidence to the courts. See attached.

I have evidence that they lied in their Declarations in the RO filed against me (Case No. : 19VER000086) I have evidence they lied to obtain a TRO against me.  
See attached emails & texts from Peter & Jim Clemente.

I told Spencer Gordon in writing on Monday, January 14th at 8am that I also planned on filing a restraining order against him for stalking and harassment and exploitation and sent him an ex-parte notice that morning at 8am (see attached)

I met with him at the Van Nuys clerks office to discuss my issues with their exploitation and he completely denied my claims had any validity so I left and filed Jim Clemente's RO to the Sheriff on Jan 14th, 2019.

Mr. Gordon continually stalked, harassed and assaulted me that morning via texts until I blocked his number, after repeatedly telling him to stop contacting me & we would work everything out in front of a judge, under oath.

Spencer Gordon also stalked me at Ben Stein's RO hearing, on Nov 9th, 2018 with another man who refused to give me his name. Spencer Gordon presented himself to me with Blair Berk (Ben Stein's lawyer) in front of a Sheriff's deputy as a witness and refused to give him his name when I asked him several times. \* Subpoena/ask Sheriff Deputy and Fridaus Dordl for statements and also get a copy of the Ben Stein restraining order hearing transcripts from 11/9/2018
