Steve Davis looks exactly like the sketches of the serial killer you are looking for and "Birch" is a dark haired crime partner in the sketches below.

I do believe he was the East Area Rapist/murderer that hurt me and my family members and all those other people and I hope that you can get his DNA and help bring closure to so many people that he harmed.

Steve Davis had a blind sister who lived at the Penny Lane home for women here in LA, so hopefully you can find her too and she might help you but I don't know all of the details about her because I met her when I was six years old and don't remember much about her.

I texted my sisters yesterday to ask them to come forward with what they know and saw.

My younger sister (Nora) responded with a reply that she said was from my other two sisters (Meagan and Katie, who were both, like myself, sexually assaulted by Steve).

I do not believe they will come forward and give any statements regarding the child rape and child sex abuse that occurred at our house by Steve Davis in Northridge, California in 1980.

I texted both of my sisters (Meagan and Katie)

again, today, directly and asked them to please call detective Argota and gave them his cell number and told them to please call and confirm the child rape and sexual abuse that occurred by Steve Davis and to identify him and to help you but they have not responded and I don't think they will come forward.

I have also asked my sisters to ask my aunts (my mother's sisters, who both lived in Los Angeles in 1980 and were adults at the time) to please come forward and to verify the child rape and child sex abuse that occurred at our house at 9020 Balcom Ave and to identify Steve Davis from the serial killer sketches you have because he looks like them exactly and to come forward; but I do not think they will.

My aunt, Nora Smith Ackerley also discouraged me from going to the police several times with this story over my lifetime and told me, "Nobody will believe the word of a six year old" and so I don't think they will be helpful or

even call to confirm the child sex abuse that happened to us at the hand of Steve Davis.

Both of my Aunts (Nora Smith Ackerley and Margaret Smith Riley) told me when I was an adult that they met Steve Davis and 'Birch' in 1980 when they lived with us because they came to our house and visited us frequently and lived nearby, and they told me they were terrified of them and they were scummy but they did not step in to help get us away from the abusive household or from these sexual predators and sexual attacks on children or to remove us from my mother's continuous abuse and frequent arrests.

I'm trying to remember more info to this story and it is coming up in bits and pieces; but there was an in home burglary in 1980, the night before we moved to New York from LA while we were all in the house and they robbed purses from sleeping people and nobody woke up so they were professionals.
