To the child rape and/or sex abuse & exploitation of children department of the LAPD;

I want to make a historic record of events.

This is my (Morgain McGovern) official statement to law enforcement regarding events of witnessing a child rape in 1980 (when I was six years old, I witnessed an 8 year old girl being raped by a grown man), and of a child exploitation (grooming, photos, offers of gifts for sex, and meetings and auditions with producers) situation with Ben Stein in 1986-1987

I've experienced intense emotional upheaval, anger, unease and overall disgust from my past experiences with Ben Stein and other child predators and rapists in Los Angeles and was triggered by recent events in these media regarding child actors admitting to being exploited by child predators in the entertainment industry and wanted to come forward and tell this story.

Everything regarding the child exploitation and child rape that happened to me was triggered in 2010 when got a literary agent and started writing the book and when I tried to report what happened to the police and the frustration and despair I felt when going through the process. I think is what triggered a very public breakdown and I spiral of events that led me to writing down the truth today and making sure it's documented.

I started writing on my blog about my experiences about being a child actor in Hollywood and was advised by professionals (Jim Clemente, FBI, retired) that I should tell law enforcement about my experiences with this man so you are aware of the situation and can proceed accordingly using your best judgement and professionalism.

I am including an incident about a child rape I witnessed when I was 6 years old in the statement because I think I told the detective in 2010 about Ben Stein as well in the report but I can't remember.

I would like to remain anonymous regarding these events with Ben Stein and also because I and my sisters were juveniles at the time of these incidents. I would like my business, my family name, my family member's names and my families businesses out of the public eye and to remain anonymous regarding this case.

I do not want my name, my company, my family's name or any of my families companies associated with this man or any part of this case publicly. Please respect my privacy and my family's privacy at all times. I (Morgain McGovern) and members of my entire family want to remain anonymous in this statement regarding the rape and child abuse/exploitation.

I met Ben Stein for the first time when we lived in Sherman Oaks, California when I was 12 years old in May or June of 1986 when he came over to interview our family and wrote a glowing article about my mom and how she helped homeless teenagers and was such a good person. (timeline and articles mentioning her and my family are attached below)

My experiences with Ben Stein continued until I after I turned 13 years old in December (15th) of 1986, he kept calling me after we moved (in Dec. 1986) to Westport, CT and he continued to call our house until March of 1987 when I was 13 and he asked me to stay overnight with him at his hotel in Manhattan.

In 1980, when I was 6, I witnessed my 8 year old sister (Katie) being raped by a grown man who came into our bedroom when we were sleeping. My sister and I shared a room and slept in a big bed together and he got into it with us in the middle of the night naked, with a flashlight.

*was told he.
~ Kidnapped an infant ~*

I believe his real name was Stephen Duane Davis (DOB 3/15/56) but he had other aliases like Keith Tracey Richardson but it has since been removed from the Megan's Law website but I have documentation if needed from the year I reported him in 2010. He was a drifter handyman that my mother let live in our garage in Northridge, CA and we lived on Balcom Ave near CSUN.

When I was an adult, I reported the child rape of my sister and my experience with him (he made me touch his genitalia because he was naked under the covers with us with a flashlight and then raped my sister in front of me) and I reported all of this to a Detective January at the Northridge, CA Police department in 2010 (and may have also told her about my other experiences later on when I was 12 with Ben Stein in the police report) but do not remember for sure, which is why I am including this part, the Ben Stein incidents might have been reported to Detective January in 2010 report of the rape, but not sure and do not remember if I told her about Ben Stein as well.

The man who I believe (and my sisters believe) raped my 8 year old sister is on the Megan's Law website and has been in violation since 1997. My family continually discouraged me from going to the police with reporting the child rape (in 2010) because they said nobody would believe me, the statue has run out of time (even though the doctors at Boston's Children's hospital in 1980 six months later discovered she had been raped) and the they said the police couldn't prosecute him so why bother digging up the past and my family told me to let it go.

They also do not want me to report this story about Ben Stein because they know it will be another scandal if it becomes public and they and I do not want any publicity about these painful events or to have our names connected with this sick pervert in any way.

My younger sister Nora has told me that she will tell the truth to law enforcement about what she knows and has said she will speak to them if they call her. She was at the swimming pool at Ben Stein's home when he took pictures of me and paid me \$50 for it. I thought he had taken photos of both of us but she told me that he didn't want to take pictures of her because he didn't think she was cute enough.

I currently blog and write about my experiences growing up in a dysfunctional family and my blog is www.morgainm.wordpress.com where I write short stories regarding my upbringing and growing up on the run with the madwoman who was my mother.

My previous literary agent is Jill Marr with the Sandra Dijkstra Literary agency in Del Mar, California and she can confirm that I have been writing publicly (blogging) about my experiences growing up on the run with a con artist mother since 2010.

My mother (Maureen Alice Smith McGovern DOB 7/2/38,) currently has dementia and is in a skilled nursing facility near Littlerock, Arkansas and is most likely dying. I do not have contact with her and have not had any contact with her for two years and before that contact was limited to about once every few years.

She was in various Federal prisons from 1992-1996 (roughly) and then again went to prison in 2004 in Texas for committing more crimes.

Timeline

May or June 1986 (Start)

In May or June of 1986 I was in the 6th grade at Mullholland Jr. High and lived in Sherman Oaks, California with my mother and three sisters on Morrison Street. We also had various people living with us at the time, either sleeping in the garage or my sisters' friends who came from other dysfunctional families worse than mine.

My mother was a con artist and was frequently arrested for her schemes, fraud, bad checks and bad behavior stemming from her mental illness which is why this behavior by him was permitted for so long.

We moved houses and changed schools about every three to six months. Some doctors have diagnosed her with borderline personality disorder but I believe she is a psychopath and a dangerous one.

While we were living in Sherman Oaks, my mother read an article in the Los Angeles Herald examiner written by Ben Stein who wrote about homeless teenagers and was a columnist for the paper.

He had written a story about homeless teenagers in the Valley and my mother contacted him and told him how she helped homeless teenagers of my older sisters' friends. I have two older sisters who were 14 (Katie) and 16 (Meagan) at the time.

My mother did let homeless people and teenagers and friends of my sisters live with us, but it always ended badly because she would use them to do illegal things for her (various forms of fraud and I do not remember the details) and most of the adult homeless people that she let live in our garage were strange and usually mentally ill.

Some of my sisters teenage friends did live with us, but there was no order or any form of real guidance or parental supervision. My mother let strange people live with us because she manipulated them to do things for her that normal people wouldn't do and she exploited young teenage kids for her own means.

It was a dysfunctional household and my younger sister (age 10) and I did our best to raise ourselves and find some sense of peace in the household but it was hard because we usually moved every three-six months.

Ben Stein coming over to the house to meet all of us

He interviewed Tyra (my sisters best friend) and took her to the 50's cafe to talk to her.

He spoke to me and was very engaging with me and I told him I wanted to be an actress. He told me I was beautiful and that he could help me get an agent and read for producers and help me get roles on tv shows.

Then article came out in the paper and checks (donations from people who read the story) started coming in from the public to help my mom financially.

My mom used the article to get a new van from Cal Worthington car dealership in Long Beach.

After the article came out, he called our house and told me that he wanted his nephew to come out to California and wanted to show him how pretty California girls were and we wanted to take pictures of me and send his nephew some photos of me.

He asked me to wear a bikini and to take pictures of me by the pool at his house.

My mom told me no but I could wear shorts and a t shirt.

She drove me and my little sister over to his house in the hills.

He introduced me to his wife in their kitchen in the hills at his home in Sherman Oaks overlooking the Valley before he started taking photos of me out by their swimming pool.

My little sister Nora was also there outside by the pool (and my mom) and I thought Ben Stein took photos of both of us together but recently when I asked her about this she said he told her no and that she wasn't "cute" enough and did not take pics of her.

He gave me a check for \$50. It was the most money I'd ever had for myself in my life.

Maybe a week or two after that, I went on two auditions within the span month to Al Burton's production offices when I was 12 to read for a part on a TV show in August or Sept of 1986 and read my lines and rehearsed with his assistant, Steve Stark, at the black office building tower at Universal in the executive building offices on the ground floor.

Steve Stark took a photo of me at Al Burton's office outside in the courtyard wearing a t shirt of a television show they were working on called "Together We Stand"

Steve Stark was in no way creepy and very professional and kind to me and I kept in touch with him later on when I came back to Los Angeles as an adult and he was very encouraging about my book and writing.

Westport, CT 1987 January-March? 238 Greens Farms Road House

We moved from California in December 1986 to Westport, Connecticut on Greens Farms Road (I think it was 243 Greens Farms Road) and then in February or March of 1987 he called my mom at our house and then asked to speak with me on the phone and asked if I would go shopping with him and then spend the night with him in a hotel when he came to Manhattan (when I was thirteen).

I believe later on she used also me as bait to get him to send money to her when we lived in Connecticut because she told me that he had sent her money to fly me out to California to visit him, but she just kept the money.

He said he was "coming out to New York for work and wanted to see me and take me shopping and spend the night with him at his hotel. Would you like that?" He specifically said this and was very simple when he said it. I think I said, " Yeah, sure! I'll bring my sisters and we'll all go shopping" or something like that and I told my mom at the time.

I think after that she was using him to send money or get money from him somehow but not sure.

I was in the 7th grade in Feb/March of 1987 at Long Lots Middle school in Westport, Connecticut.

(Timeline Cont.)

After Ben Stein asked me to stay with him at hotel in Manhattan,
I think my mom got money out of him somehow.

June 1987- August 88

We moved from the house on Greens Farms road in Westport To a house on Hoydens lane in Fairfield, Connecticut and I started the 8th grade at Tomlinson Middle School, in Fairfield, CT

Fairfield, CT 1988,

We were living at the red farmhouse on Hoydens Lane (I don't remember the address) I believe she was speaking to Ben Stein again regarding political things and he was trying to get her to plant information in the press somehow and it was all very shady but I think he was trying to get her in trouble and arrested and I think it was an election year, (1988?) Something about trying to make the Democrats look bad, but I was in the 8th grade and did not really care about these issues but I remember them talking on the phone and trying to outwit each other and he got her in trouble somehow.

That was the last I think my mother had any contact with Ben Stein that I know of.

Los Angeles, 1992-1993?

When I was 18 years old in the early 90's my mom went to federal prison and I moved back to Los Angeles and lived with my father for a few months and then got my own apartment and went to Stella Adler Theatre and was acting and doing plays and theatre and was waitressing in Los Angeles.

After I moved back to Los Angeles, I went in for an audition to Al Burtons' offices in the Miracle Mile area at the urging of my talent agent who encouraged me to call any connections I had to get auditions and try to get a role.

Al Burton called me in for a meeting and I went in to the audition at Al Burton's offices when I was 19, he gave me Ben Stein's home phone number at the meeting and he encouraged me to call Ben Stein.

I did call the number to see what Ben would say and wanted to confront him and ask him about what he said and did and he pretended like he did not remember me and I hung up on him.

Ben Stein is a coward and a bad liar. He did remember me and I think he was scared of what I was going to say about him.

I did keep in touch with Steve Stark over the years since I was 19 and doing theatre as an actress in Los Angeles and I emailed a copy of my book to Steve Stark (Al Burton's assistant who was now working at Paramount) when I was in (my 30's in about 2003-2005) a copy of my book when I lived in San Diego and he was encouraging but said he emailed my stories to the film department, but they passed on it.
